The patient may request additional medical services from Dr. Kordonowy’s practice beyond those listed in this agreement. The patient will be financially responsible for the practice’s charges for such services not included in the membership. Fees will be collected at time of service. In the event this is not possible, the patient will be required to remit payment within thirty (30) days of the services provided.

When Dr. Kordonowy is on vacation or ill another highly qualified physician will go to the hospital to see the Inpatient Advocate Service patients. All patient needs will be triaged by Dr. Kordonowy’s nurses and patients may be referred to other selected practices for walk-in appointments or the emergency room if needed. Patients will be financially responsible for services provided by other health care offices and hospitals.

There may be times of “technical difficulties’ such as poor to no cell phone reception, computer and internet failure, acts of Nature such as hurricanes, storms, etc... that may cause disruption to medical services. Dr. Kordonowy is not responsible for such occurrences. Laps of services due to these events does not entitle patient to recourse.

Memberships will renew automatically each year. Patients may cancel this agreement for any reason with a 90-day notice in writing to Dr. Kordonowy, PO Box 7368, Fort Myers, FL 33919. Premier memberships will receive a prorated refund 90 days from written notice.

The enrollment in Dr. Kordonowy’s practice is completed with the execution of receipt of payment for the Membership and signature of patient and physician.

Patients under the age of 18 must have adult signature also.
